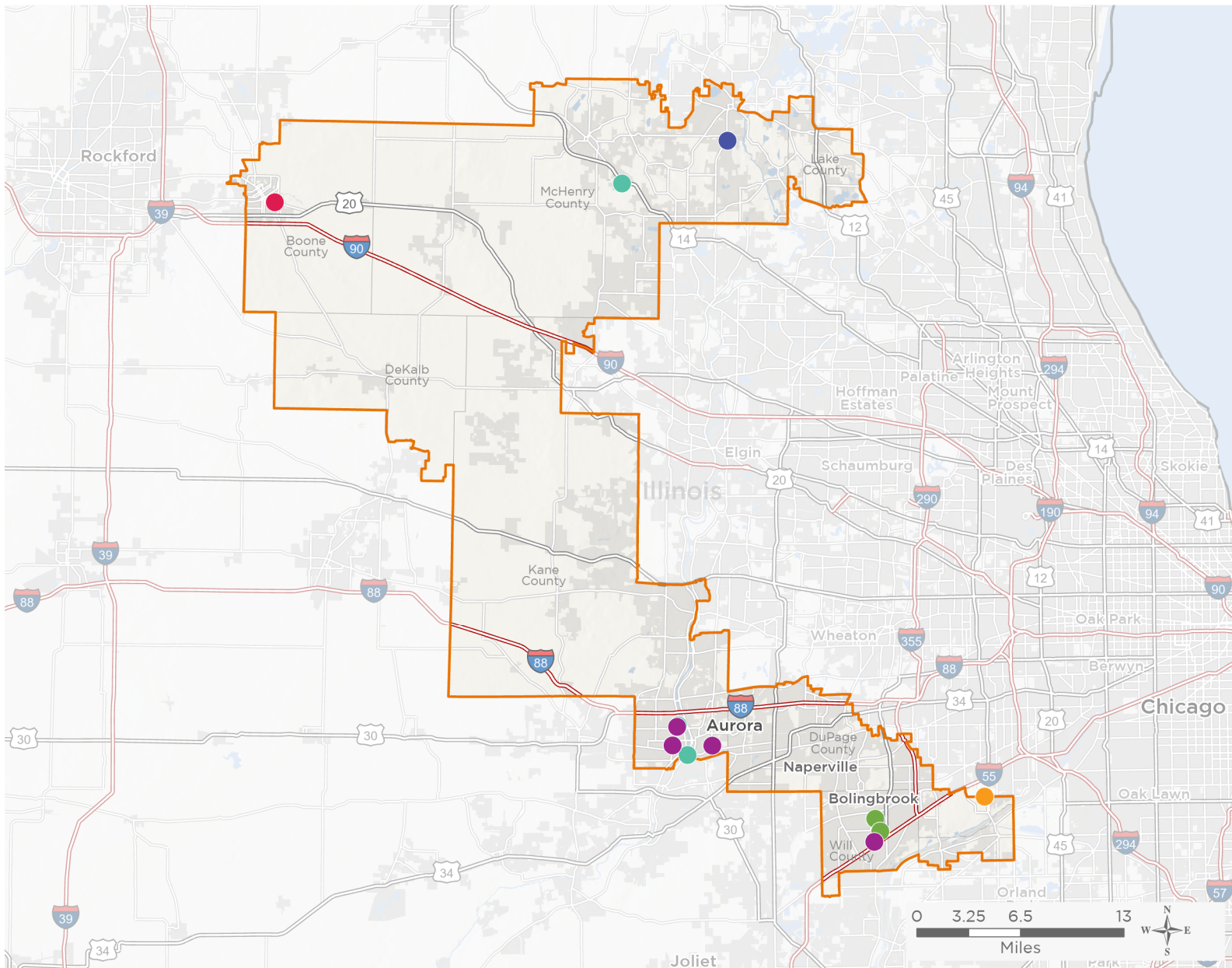

Federal investments represent the total funding from the federal Health Center Program to grantees with a presence in the state in 2021.
