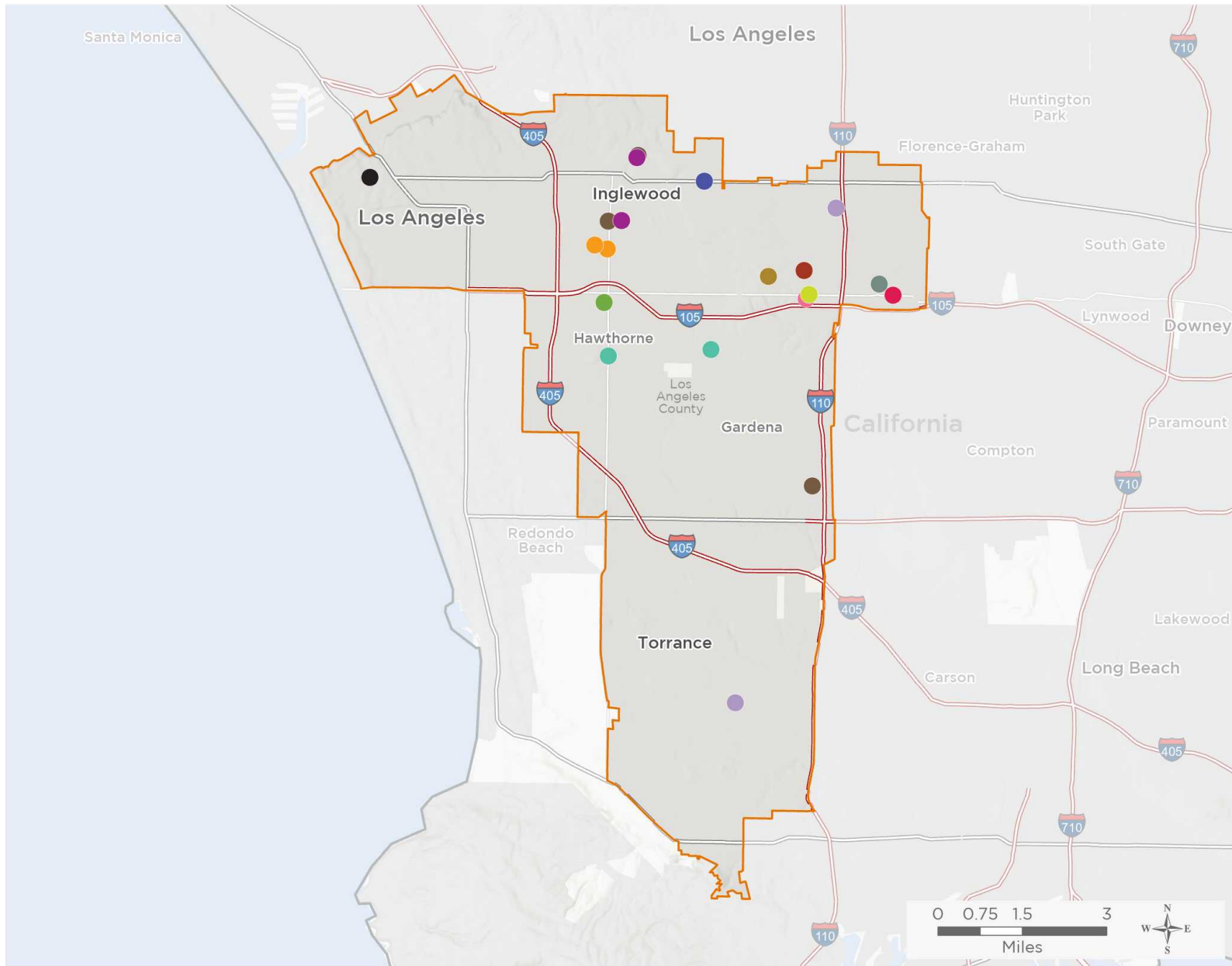




The 14 federally-funded health center organizations with a presence in California's 43rd Congressional District leverage **\$53,529,160** in federal investments to serve **353,343** patients.
