# **Community Health Worker Supervisor: 101 & 201**

# When: September 12 – October 4, 2023

**Introduction:** The NACHC Quality Center is excited to offer Community Health Worker Supervisor: 101 & 201 as a course offering in the fall 2023 Health Center

Professional Development Program. The Quality Center recognizes the critical importance of providing access to training opportunities for health center professionals to build skills, develop competencies, and advance careers while driving improved patient care and health outcomes. More specifically, these trainings help to achieve the Quintuple Aim: improved health outcomes, improved patient experiences, improved staff experiences, reduced costs, and equity.

**Course Description:** This course provides supervisors of CHWs with training to ensure success in their role. Participants will learn strategies to maximize the skills and deployment of CHWs in the healthcare setting, including integration within the care team, interfacing with the community, and using data to drive decisions.

**Who Should Apply:** Health center staff who supervise CHWs (or staff performing similar roles to CHWs such as patient navigators).

**Course Content:** A six-part series: four, 90-minute virtual courses and two, 60-minute Office Hours. Individuals registering for this course participate in both 101 and 102.

**Instructors:** Faculty from Northwest Regional Primary Care Association (NWRPCA).

**Kelly Volkmann, MPH**, managed CHWs in a clinical setting for 13 years before joining NWRPCA as the Project Director of the CHW Institute in 2021.

**Seth Doyle, MA**, has been working with CHWs and CHW programs with NWRPCA for over 16 years. Together, they bring a wealth of experience and expertise to their CHW Supervisor trainings.
