Improve and Protect the Nation's Health, seeks vendors for regional trainings offered through a national learning community to support systems and process changes that increase cancer screening in community health centers.

#### RFP SERVICES DESIRED

Through this Request for Proposals (RFP), NACHC is seeking one or more vendors to collaborate with the NACHC team in providing support for health center system and process changes that increase cancer screening, including four regional in-person trainings to promote evidence-based cancer screening interventions and quality improvement approaches, with attention to closing care gaps.

#### **SCOPE OF WORK & DELIVERABLES**

NACHC seeks vendor(s) with a variety of subject matter expertise. Interested vendors should select at least (1) area of interest from the list below. Vendors can indicate interest in more than one area in a single application, if applicable.

- Quality Improvement (QI) & Performance Improvement Trainer and Coach. In collaboration with the NACHC and ACS team, provide training in application of rapid cycle improvement systems for evidence-based cancer screening interventions as part of a systems approach to performance improvement. An experienced QI professional and trainer is sought who can coach health centers in improvement strategies and applications, with attention to closing care gaps. Ideal candidate has experience not only in working with health centers but also engaging state/regional primary care associations (PCAs) and/or health center controlled networks (HCCNs) to leverage state/regional QI and transformation efforts in support of member health centers.
- Meeting and Events Coordinator. Support the NACHC team in selection of a regional training site and managing on-site logistics and coordination with the event manager. Ideal candidate is a PCA/HCCN who plans to leverage an existing/planned health center event to offer this additional training or a QI Trainer (see above) whose team encompasses this expertise.
- Training Materials Development Consultant. Collaborate with the NACHC in development of training and curriculum on evidence-based cancer screening as part of a systems approach to change. Prepare and package training materials for four Regional Trainings, to include items such as instructor guide, pre/post learning, and presentation materials.
- **Health Writer/Research**. Interview three health centers who are among the highest performers nationally in cancer screening to identify components of their infrastructure, care delivery, people systems that support this success. Analyze the cost-effectiveness of the learning community approach and prepare a business case for a systems approach to cancer screening and implementation of system-wide interventions and strategies for improved cancer screening.
