Numerator:

Patients with a repeat visit for blood pressure monitoring in the four weeks after the first visit with an uncontrolled baseline blood pressure

- First encounter found after the visit with uncontrolled baseline blood pressure meets these criteria
 - Qualifying Blood Pressure Visit (see value set tab)
 - o Systolic BP or diastolic BP recorded on the encounter date
 - o Date is less than four weeks after the first visit with an uncontrolled baseline blood pressure

Denominator:

Patients aged 18-85 years of age, who had at least one outpatient visit in the first eleven months of the measurement year, who have a diagnosis of essential hypertension documented during that outpatient visit, and who have an uncontrolled baseline blood pressure at the time of that visit.

- Age 18-85 at the end of the measurement period AND
- First encounter found in the first 11 months of the last 12 months with the following:
 - o Qualifying Blood Pressure Visit (see value set tab)

AND

- o Diagnosis of Essential Hypertension overlaps encounter date
- o And one of these

Denominator:

Encounters in the period where patients 18-85 years of age had a diagnosis of essential hypertension within the first six months of the measurement period or any time prior to the measurement period.

- Age >=19 and <86 at end of measurement period
- Active diagnosis of Essential Hypertension prior to or within the first 6 months of the measurement period.
- · Qualifying encounter occurring during the filtered period
- Lowest systolic BP measurement at the qualifying encounter is \geq 140 mmHg OR
- Lowest diastolic BP measurement at the qualifying encounter is ≥90 mmHg

Numerator:

Patients whose follow-up blood pressure is at least 10 mmHg less than their baseline blood pressure or is adequately controlled. If a follow-up blood pressure reading is not recorded during the measurement year, the patient's blood pressure is assumed "not improved."

- Follow-up Physical Exam (min 6 months after first visit) in the last 12 months AND
- Follow-up BP systolic result < 140 mmHg OR
- · Delta of systolic BP is at least 10 mmHg less than the first visit baseline BP

Denominator:

Patients aged 18-85 years of age, who had at least one outpatient visit in the first six months of the measurement year, who have a diagnosis of essential hypertension documented during that outpatient visit, and who have uncontrolled baseline blood pressure at the time of that visit.

- · Age 18-85 at the end of the measurement period
- · Qualifying Visit (see Technical Specifications) in the first 6 months of the last 12 months
- · Diagnosis of Essential Hypertension overlaps qualifying visit
- Systolic BP >= 140 mmHg

- Kidney Transplant before end of measurement period
- · Hemodialysis before end of measurement period
- · Peritoneal Dialysis before end of measurement period
- Pregnancy
