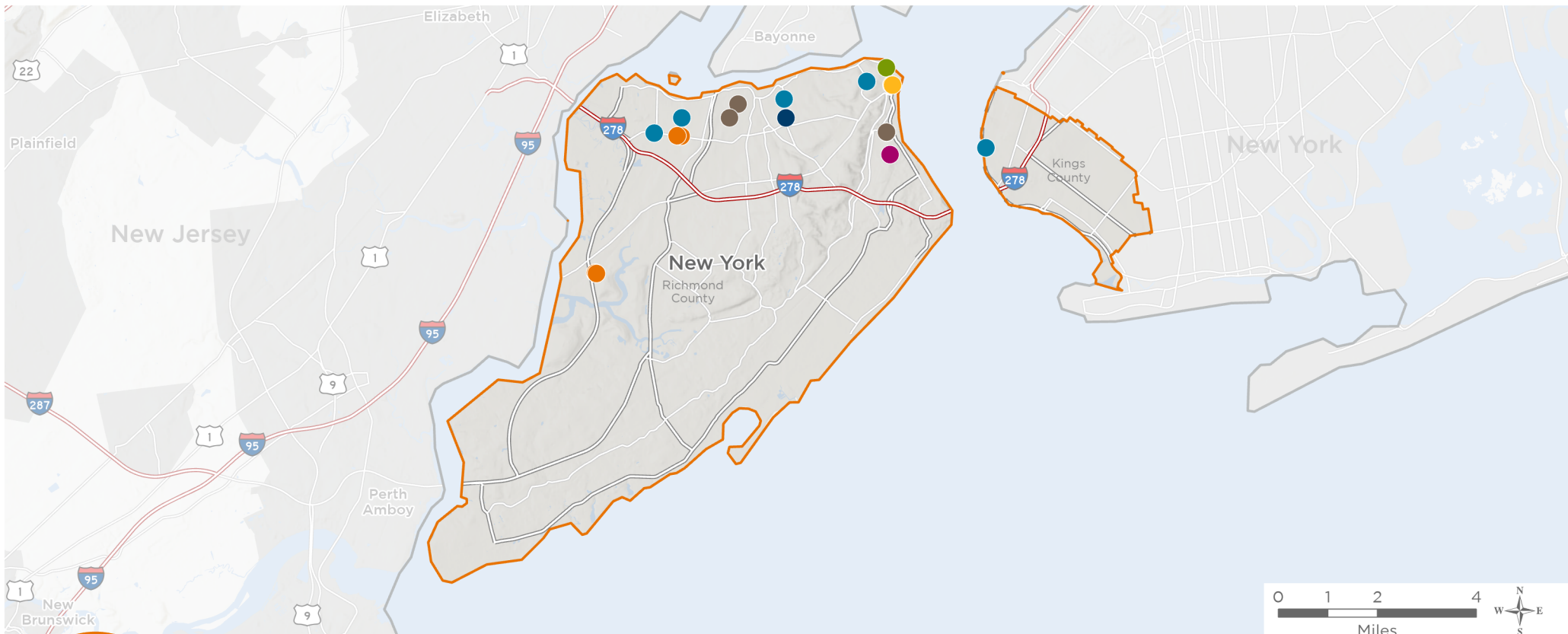




The 7 federally-funded health center organizations with a presence in New York's 11th Congressional District leverage **\$51,264,384** in federal investments to serve **572,858** patients.
